Overview

This Appendix confirms and provides the **complete, unedited, index of all identified links and documents** published on YesDude.com, a website **operated by David Charles Olesen**. **Mr Olesen intentionally operates** this website which function as a **centralized repository for the collection, organization, and public dissemination of unauthorized materials resulting in personal, financial, and reputational harm to Maureen G. Mulvaney and her family members.**

This index identified **over 190 individual unauthorized items** which have been collected directly from the Yesdude.com website, consisting of extremely sensitive documents, web pages, and externally hosted materials that expose **personal, legal, financial, and highly sensitive family-related information.**

The scope, structure, and sheer volume of content demonstrate a **systematic, deliberate, sustained and ongoing pattern of publication, distribution, and conduct of David Olesen**, significantly increasing the risk of identity theft, financial harm, and personal safety concerns.

Key Finding: These materials demonstrate the unauthorized exposure of highly sensitive personal, financial, medical, and legal records across multiple jurisdictions.
