I am submitting a **FORMAL Domain Abuse Complaint** regarding **YesDude.com**, currently registered through easyDNS Technologies, Inc. and operated by **David Charles Olesen**.

This domain is being used to publish and distribute **over 190 documents containing highly sensitive personal identifying information (PII)**, including residential addresses, phone numbers, financial records, family information, and court-related materials across multiple jurisdictions.

In addition, the website includes **misleading and unverified legal representations**, including public claims of legal proceedings and statements that I “failed to respond to service,” despite no lawful service or verifiable court record.

This activity has already resulted in **documented identity theft and financial harm** and continues to cause ongoing personal, reputational, and security risks.

I respectfully request that easyDNS:

1. **Initiate an immediate abuse review** of YesDude.com
2. **Investigate violations of your Acceptable Use and Privacy policies**
3. **Preserve all relevant account, DNS, and registration records** associated with this domain
4. Provide **written confirmation of receipt and next steps**
