On February 3, 2023, at approximately 1708 hours, I was dispatched to 3123 S Don Carlos Cir in reference a custodial interference. Call comments stated there was a court order for visitation with grandchildren however the other party was not home and stated they left the state.

Upon arrival I spoke with Maureen Mulvaney ([REDACTED]) who I identified via AZ ID. Maureen stated she has visitation rights to meet with her grandchildren on the Friday proceeding the first Saturday of each month at 1700 hours. Maureen stated that she sent David Olesen ([REDACTED]) (father of grandchildren), who I identified verbally over the phone, a text message at approximately 1700 hours stating that she was at his residence and to send the children out as per usual. Maureen mentions she received a message back from David stating that the children were out of state and that she could not pick them up today. Maureen provided me with David's phone number (480-510-3262). Maureen handed me a court document with the agreement that was issued. Maureen was concerned for the safety of the children and wanted the terms of the agreement to be followed. Maureen states a seven days' notice regarding any changes need to be communicated between parties and that David failed to do so.

I contacted David via telephone (480-510-3262) and David states his children are out of the country with his wife. David admitted to failing to give a seven days' notice to Maureen that the children were going to be out of the country. David continued to tell me that his wife has full custody over the children. I was unable to contact the mother due to her being out of the country.

I informed Maureen that I will write a report on this particular matter documenting the interaction.
