## SYNOPSIS -

ON 02/18/2023 OFFICERS CONTACTED MAUREEN MULVANEY OVER THE PHONE IN REFERENCE TO A INTERFERING WITH JUDICIAL PROCEEDINGS CALL FOR SERVICE. MAUREEN INFORMED OFFICERS THAT SHE WAS RECENTLY GRANTED GRANDPARENTS RIGHTS THROUGH THE COURT DUE TO HER DAUGHTER AND MOTHER OF HER GRAND CHILDREN PASSING AWAY AND THE CHILDRENS FATHER, DAVID OLSEN NOT ALLOWING HER TO SEE HER GRANDCHILDREN. ON 02/18 AT 0900 MAUREEN WAS SUPPOSED TO HAVE A SCHEDULED PHONE VISIT WITH HER GRANDCHILDREN AND THE NUMBER THAT SHE NORMALLY CALLS IS TURNED OFF. MAUREEN STATED THAT DAVID RECENTLY UN ENROLLED THE CHILDREN FROM SCHOOL AND LISTED HIS HOUSE FOR SALE. MAUREEN STATED THAT DAVID RECENTLY REMARRIED AND THE CHILDREN HAVE BEEN GOING BACK AND FORTH FORM THE PHILIPPINES WITH HIS NEW WIFE.

ON 02/18/2023 I RECEIVED THIS REPORT FOR REVIEW. UPON RECEIPT, I CONDUCTED RECORD CHECKS ON DAVID OLSEN AND MAUREEN MULVANEY. I LOCATED RMS AND MVD RECORDS FOR BOTH SUBJECTS.

IN REGARDS TO DAVID AND MAUREEN I LOCATED NO OTHER PHOENIX POLICE DEPARTMENTAL REPORTS RELATED TO DOMESTIC VIOLENCE BETWEEN THE TWO PARTIES.

ON 05/31/2023 I RECEIVED THIS REPORT TO REVIEW FOR FURTHER INFORMATION. UPON REVIEW I LEARNED THAT MAUREEN WAS GRANTED GRANDPARENTS RIGHTS FOR HER TWO GRANDCHILDREN, MAUREEN IS ALLOWED TO HAVE TELEPHONE CONTACT WITH THE CHILDREN ON EVERY SATURDAY AT 0900 HOURS AND IN PERSON VISITATION ONCE A MONTH REFERENCE CASE NUMBER [REDACTED] MAUREEN RECENTLY LOST HER DAUGHTER AND HER GRANDCHILDREN LIVE WITH THEIR FATHER DAVID OLSEN, DAVID HAS NOT BEEN FOLLOWING THE COURT ORDER.

I CALLED MAUREEN AND SHE INFORMED ME THAT SHE HAS NOT SEEN OR SPOKEN TO HER GRANDCHILDREN SINCE JANUARY. MAUREEN CALLED TO SPEAK WITH THE CHILDREN ON FEBUARY 3RD AND NO ONE ANSWERED, MAUREEN THEN CALLED ON THE 18TH AND NO ONE ANSWERED.

ON AN UNKNOWN DATE MAUREEN CALLED DAVID AND ILYN OLESEN , DAVIDS NEW WIFE ANSWERED THE PHONE. ILYN YELLED OUT TO THE CHILDREN "IT'S MAUREEN DO YOU WANT TO TALK TO HER?" AND THE CHILDREN RESPONDED "NO". ILYN THEN HUNG UP THE PHONE.

MAUREEN AND DAVID HAVE HAD SEVERAL COURT HEARINGS SINCE THIS REPORT WAS MADE AND DAVID ADVISED THE COURTS THAT ILYN AND THE CHILDREN ARE ON A VACATION IN THE PHILIPPINES. MAUREEN ADVISED ME THAT NOTHING HAS BEEN CHANGED AND SHE HAS NOT BEEN ABLE TO HAVE CONTACT WITH HER GRANDCHILDREN DESPITE THEM HAVING SEVERAL COURT HEARINGS SINCE SHE LAST SAW OR HEARD FROM THE CHILDREN IN JANUARY.

MAUREEN HAS SEEN SEVERAL PHOTOGRAPHS OF THE CHILDREN IN THE PHILIPPINES THROUGH SOCIAL MEDIA.

ON 06/08/2023 I CONTACTED CITY OF PHOENIX PROSECUTOR LAURA AND PROVIDED HER WITH THE INFORMATION REGARDING THIS REPORT AND SHE INFORMED ME THAT THIS INCIDENT WAS TO BE RESOLVED WITHIN FAMILY COURT AND NOT THROUGH CITY COURT.

I ATTEMPTED TO CONTACT DAVID SEVERAL TIMES AFTER RECEIVING THIS REPORT, HE HAS NOT RETURNED MY CALL.
