ON 02/18/2023 AT APPROXIMATELY 0900 HOURS DAVID COMMITTED INTERFERENCE WITH A JUDICIAL PROCEEDING BY DISOBEYING COURT ORDER [REDACTED] WHEN THE PHONE NUMBER TO BE USED TO CONTACT THE JUVENILES FOR VISITATION HAS BEEN TURNED OFF AND NO OTHER CONTACT INFORMATION WAS PROVIDED.

NARRATIVE

ON 02/18/2023 I SPOKE WITH MAUREEN BY TELEPHONE. MAUREEN WAS EMOTIONAL ON THE PHONE HAVING TO COMPOSE HER SELF. SHE EXPLAINED THAT SHE BELIEVES HER GRAND CHILDREN HAVE BEEN TAKEN TO THE PHILIPPINES BY THEIR FATHER. MAUREEN WENT ON TO EXPLAIN THAT HER DAUGHTER, THE CHILDREN'S MOTHER, COMMITTED SUICIDE IN 2019. SHE WENT TO FAMILY COURT AND OBTAINED A COURT ORDER THAT MANDATED IN PERSON VISITATION WITH THE CHILDREN ONCE A MONTH AND PHONE VISITATION EVERY SATURDAY AT 0900 HOURS. MAUREEN SAID THINGS WERE GOING WELL UNTIL RECENTLY WHEN DAVID MARRIED HIS THIRD WIFE ILYLN.

MAUREEN STATED THAT SHE NEVER EXPECTED DAVID TO TRY TO KEEP THE CHILDREN AWAY FROM HER. MAUREEN MADE A REPORT EARLIER THIS MONTH WHEN SHE WAS DENIED THE ABILITY TO HAVE HER IN-PERSON VISITATION. DAVID SAYING THAT THE CHILDREN WERE OUT OF STATE WITH HIS NEW WIFE AND THEN STATING THE CHILDREN WERE IN THE PHILIPPINES WITH HIS NEW WIFE.

MAUREEN HAS BECOME CONCERNED FOR THE CHILDREN'S WELL BEING. STATING THAT DAVID'S BEHAVIOR IS OUT OF CHARACTER. MAUREEN HAS REACHED OUT TO THE FBI, STATE DEPARTMENT AND THE AMERICAN EMBASSY LOCATED IN THE PHILIPPINES.

MAUREEN STATED ADDING TO HER CONCERN IS THE FACT THAT DAVID UNENROLLED THE CHILDREN FROM SCHOOL [REDACTED] ELEMENTARY, [REDACTED], [REDACTED] ON FEBRUARY 1, 2023 AND DID NOT REQUEST RECORDS BE SENT TO ANOTHER SCHOOL. AS WELL AS THE FAMILY HOME BEING SOLD.

MAUREEN REPORTS THAT DAVID WORKS FOR [REDACTED] AS AN ONLINE PROGRAMMER. HIS POSITION IS A REMOTE POSITION SO DAVID CAN WORK FROM ANY WHERE.

MAUREEN IS CONCERNED THAT SHE WILL NEVER SEE HER GRANDCHILDREN AGAIN.

I GAVE MAUREEN THE EMAIL ADDRESS FOR VIRTUAL BLOCKWATCH TO SUBMIT HER PHOTOS OF THE HOUSE UP FOR SALE AND COPY OF THE COURT ORDER. I ALSO GAVE DIRECTION FOR ACCESSING THE VICTIM RIGHTS PAMPHLET ONLINE AS WELL AS PROVIDED THE DEPARTMENT OF SAFETY HOTLINE NUMBER.

MAUREEN DOES WANT DAVID HELD ACCOUNTABLE FOR VIOLATING THE COURT ORDER AND WILL ASSIST AS NEEDED.
